- This absolute decline is made even more stark when compared to the United States and adjusted for the number of workers. According to a 2023 study, between 2014 and 2021, business investment per worker (inflation-adjusted, excluding residential construction) decreased by \$3,676 (to \$14,687) compared to growth of \$3,418 (to \$26,751) in the United States. Put differently, in 2014, Canadian businesses invested 79 cents per worker for every dollar invested in the United States. By 2021, that level of investment had declined to just 55 cents per worker.
